ROUTES TO SHOW:

Set GPS to 2962 Shafto Rd, Tinton Falls, NJ

Directions from the North:

Garden State Parkway to exit 100A towards Freehold. Merge onto 66W, turn right onto Shark River Road. Right turn into Shafto Road.

Directions from the South:

Garden State Parkway North to exit 100C NJ-66 W towards Freehold. Merge onto 66W Right turn onto Shark River Road, Right turn onto Shafto Road. ***GPS may take you exit 105, but this will put you on the wrong side of the road. To avoid making a U-turn please use exit 100A or 100C***

From 295: Take Exit 60 to I-195E to NJ-138E. Take Exit 35B to merge onto NJ-34N toward Matawan. Follow to Shafto Road. Building on Right.

IMPORTANT EVENT INFO PLEASE READ:

Due to the current Covid-19 pandemic, some additional rules and regulations will be in place for this event. As the state is changing rules every few weeks, these rules may change at any time.

- Indoor crating will only be allowed in designated areas on the agility turf. Dogs that are aggressive to passing dogs/people or that continuously bark or cry will not be permitted to crate anywhere inside the building.
- No spectators or unentered persons or dogs are allowed to enter the building.
- **Masks must be worn by everyone at all times while inside the building regardless of vaccination status.**
- Hospitality: No food will be distributed inside for workers. During Covid, we will not allow persons to eat inside the building. Exceptions are those eating in private offices such as office staff, Trial Chairs, Trial Secretaries, and Judges.
- Attendees should come prepared with their own food, water and other personal needs. Competitors should plan to eat outside or in their cars.
