Exhibitor & VMO Paul Mount will also be available to measure dogs Saturday ONLY.** If the "Will dog need to be measured?" says YES, you will need to have a valid permanent height card, valid temporary measurement slip or you will need to be measured by a VMO. Dogs entered on Friday will not be measured and will run at their entered jump height. It is the exhibitor's responsibility to get their dog measured and to know the jump height card rules.

Any participant who is not feeling well, please stay home!

Covid-19 Pandemic and Masks: **EVERYONE** will be required to wear masks indoors regardless of their vaccination status while in any public areas such as the bathroom, crating area, outside the rings, during briefings/walkthroughs and while volunteering to work classes. **Fully vaccinated competitors who have shown proof of vaccination will be permitted to lower their Mask while in the ring running but must enter and exit the ring wearing a mask as long as you show your Premier provided bracelet at the start line.** Please come prepared to show proof of vaccination status if you would like to run maskless. You will be issued a Premier Bracelet. You will need to show this bracelet at the start line to lower your mask to run. As long as you keep this bracelet you will not have to show proof again at future events. If you lose this bracelet, you can show proof of vaccination again to be issued a new one. Premier will not be keeping a list of vaccinated competitors.

Anyone who is not fully vaccinated against Covid 19 must wear a mask covering nose and mouth at all times when inside the facility including when running your dog.

Judges, Club Officials & Trial Secretaries who are fully vaccinated and have been issued a Premier bracelet may remove their masks while in the Trial Secretaries Office and Club Hospitality Room. Judges who are fully vaccinated and have shown proof may choose to judge maskless but must enter and exit the ring wearing a mask. Judges must also wear a mask during all briefings

Crating: Climate controlled Indoor Crating is allowed in designated areas. You must bring a tarp to place under your crate.

Parking: Please Park where Premier Staff directs you. Absolutely no double parking will be permitted. If you do not park within the lines, you will be asked to move. No day parking for RV's that take more than one parking space. Do not park in any business neighbor's lot unless directed by Premier Staff. There is limited handicapped parking, please arrive early to obtain a spot. Unauthorized camping and overnight parking are not permitted at Premier Sports Center. Vehicles not in compliance with parking rules will be towed at the owner's expense.

Dog Exercise Areas: Premier Sports Center has 4 acres of grass for you and your dogs to enjoy. All dogs need to be on leash and under control at all times while on Premier Sports Center premises, both indoors and outside. The only exceptions for off leash is when at the practice jump or in the ring. Poop bags are to be discarded in outside trash receptacles only. Do not walk your dog on our business neighbor's properties. Pay attention to your dog and pick up after your dog. Anyone seen in person or on video not picking up after their dog or walking on the neighbor's property will be subject to a bench hearing and immediate excusal from the Center for the remaining day(s) of the trial. Do not let your male dog lift its leg on the building, front landscaping, or on any item a human needs to handle.

Please be considerate of the public restrooms. Trashcans will be placed in the bathrooms for proper disposal of paper products other than toilet paper. No dogs allowed in public restrooms. Personal chairs/handicap chairs will not be allowed on the turf field. We will provide bench seating in the front of the rings for all to use. Please remove your personal belongings when your class has ended.

Smoking: Is not permitted inside our facility and not encouraged outside near others. We prefer if you must smoke that it is done inside your vehicle and that your butts are discarded in your vehicle ashtray.

Sports Center Hours: The Center will close and doors will be locked approximately one hour after the last run has been completed for the day. Be prepared.

Hotels: The Hotel Info that we have provided on our website/premium are an extension of the trial site. Reports of barking dogs left unattended in the hotel or other behavior deemed inappropriate by the hotel management may be subject to a bench hearing. You must clean up after your dogs at the hotel. You are responsible for any damage your dog does to hotel property.

Good Sportsmanship: Please treat others with kindness and respect.

Absolutely no aggressive behavior will be tolerated by a person or dog towards another. Any person or dog who is seen acting in an aggressive manner will be asked to leave and no refund will be given and may be subject to a bench hearing. If you have an issue with a person or dog please see the Club Trial Chairman immediately. If you have an issue with the building, property, equipment, parking lot, please see a Premier Member.

Handlers with potential conflicts are asked to walk the Excellent/Master courses with an EARLIER height group if the conflict would mean you can't walk with your height class. If you aren't sure if you will have a conflict, play it safe and walk early! You can also **run at the end of the earlier height group or at the beginning of your height group** if that helps ease your conflict. **We do realize that handlers with multiple dogs will have some conflicts.** Conflicts can ONLY be marked in ex/mas classes unless you are running multiple dogs in that class. ALL classes that have 1 walk thru take precedence. If you need assistance with a potential conflict please ask. We would rather assist early than have anyone angry or panicked while ring side. **This is a game and we should all be having fun with our dogs!**

This is a preliminary judging schedule which is contingent upon the move-up of entries that may not have been received yet. Final numbers may differ as the chart below is created before the final closing.
