There MAY be an official measurer at this trial. We are expecting an AKC rep to be on site for this event, IF they are there, they can perform official measurements. If not, dogs needing to be measured will need to be measured by one of the judges before running. Any measurement done by a non VMO judge is only valid for that event. If the "Will dog need to be measured?" says YES, you will need to have a valid permanent height card, valid temporary measurement slip, or you will need to be measured by a VMO. Dogs entered on Friday will not be measured and will run at their entered jump height. It is the exhibitor's responsibility to get their dog measured and to know the jump height card rules.

VERBAL MOVE-UPS WILL NOT BE ACCEPTED OR PROCESSED. If you are entered in multiple trials, you need to send a separate move-up request for EACH Trial AND EACH DOG.

Again, move-up requests MUST be received in writing via email/mail by 6 pm the Monday before the event per AKC rules. Day-to-day move-ups must be done onsite and will not be accepted via email. See premium for details.

NO SETUP UNTIL Saturday morning! The site will open at 6:30am each day.

Premier Sports site rules:

Any participant who is not feeling well, please stay home!

Crating: Climate controlled Indoor Crating is allowed in designated areas. You must bring a tarp to place under your crate.

Parking: Please Park where Premier Staff directs you. Absolutely no double parking will be permitted. If you do not park within the lines, you will be asked to move. Do not park in any business neighbor's lot unless directed by Premier Staff. Vehicles not in compliance with parking rules will be towed at the owner's expense. There is limited handicapped parking, please arrive early to obtain a spot. If you need help finding a parking space, you may temporarily park in front of the building and ask for Premier Staff to help you park.

Dog Exercise Areas: Premier Sports Center has 4 acres of grass for you and your dogs to enjoy. All dogs need to be on leash and under control at all times while on Premier Sports Center premises, both indoors and outside. The only exceptions for off leash is when at the practice jump or in the ring. Poop bags are to be discarded in outside trash receptacles only. Do not walk your dog on our business neighbor's properties. Pay attention to your dog and pick up after your dog. Anyone seen in person or on video not picking up after their dog or walking on the neighbor's property will be subject to a bench hearing and immediate excusal from the Center for the remaining day(s) of the trial. Do not let your male dog lift its leg on the building, front landscaping, or on any item a human needs to handle. Please be considerate of the public restrooms. Trashcans will be placed in the bathrooms for proper disposal of paper products other than toilet paper. No dogs allowed in public restrooms. Personal chairs/handicap chairs will not be allowed on the turf field. We will provide bench seating in the front of the rings for all to use. Please remove your personal belongings when your class has ended.

Smoking: Is not permitted inside our facility and not encouraged outside near others. We prefer if you must smoke that it is done inside your vehicle and that your butts are discarded in your vehicle ashtray.

Sports Center Hours: The Center will close and doors will be locked approximately one hour after the last run has been completed for the day. Be prepared.

Hotels: The Hotel Info that we have provided on our website/premium are an extension of the trial site. Reports of barking dogs left unattended in the hotel or other behavior deemed inappropriate by the hotel management may be subject to a bench hearing. You must clean up after your dogs at the hotel. You are responsible for any damage your dog does to hotel property.

Good Sportsmanship: Please treat others with kindness and respect.

Absolutely no aggressive behavior will be tolerated by a person or dog towards another. Any person or dog who is seen acting in an aggressive manner will be asked to leave and no refund will be given and may be subject to a bench hearing. If you have an issue with a person or dog please see the Club Trial Chairman immediately. If you have an issue with the building, property, equipment, parking lot, please see a Premier Member.

Course map procedures — PLEASE READ: Per AKC rules as of 10/1/2021, course maps **WILL NOT** be available until the day of the trial. Fast Times will no longer email course maps to exhibitors. Course maps will be posted on site. Maps will also be posted on Fast Times website **the day of the trial before the start of the first walk-thru. Printed maps will NOT be handed out to exhibitors.** Please bring a phone or tablet that you can use to access the online maps, or that can take a photo of the posted maps.

Please note: ALL the times after the first walk-thru are approximate – DO NOT wait and arrive close to the time listed. We are not responsible if you show up late because you thought the class would not start until the times shown below. Please remember that by mid-day – the times may be as much as ¼-1 ¼ hours off. JUDGE'S BRIEFINGS WILL ONLY BE AT THE BEGINNING OF EACH CLASS – NOT BEFORE EACH JUMP HEIGHT

Handlers with potential conflicts are asked to walk the Excellent/Master courses with an EARLIER height group if the conflict would mean you can't walk with your height class. If you aren't sure if you will have a conflict, play it safe and walk early! You can also **run at the end of the earlier height group or at the beginning of your height group** if that helps ease your conflict. **We do realize that handlers with multiple dogs will have some conflicts.** Conflicts can ONLY be marked in ex/mas classes unless you are running multiple dogs in that class. ALL classes that have 1 walk thru take precedence. If you need assistance with a potential conflict please ask. We would rather assist early than have anyone angry or panicked while ring side. **This is a game and we should all be having fun with our dogs!**

This is a preliminary judging schedule which is contingent upon the move-up of entries that may not have been received yet. Final numbers may differ.

These times are only approximations. The Judges, the Club & the Trial Secretary will not be held to anything other than the start times for the first class of each day.
