**There WILL be an official measurer at this trial Saturday & Sunday only.** Exhibitor Janet Budzynski is a VMO and will be measuring dogs on Saturday and Sunday ONLY. If the "Will dog need to be measured?" says YES, you will need to have a valid permanent height card, valid temporary measurement slip or you will need to be measured before running. Dogs entered on Friday will need to be measured by the judge before running. This measurement will be valid of Friday only. It is the exhibitor's responsibility to get their dog measured and to know the jump height card rules.

**Move-up requests MUST be received by 6 pm the Monday before the event per AKC rules. Day to day move ups must be done onsite and will not be accepted via email. See premium for details.**

**Course map procedures — PLEASE READ:** Per AKC rules as of 10/1/2021, course maps **WILL NOT** be available until the day of the trial. Fast Times will no longer email course maps to exhibitors. Course maps will be posted on site. Maps will also be posted on Fast Times website **the day of the trial before the start of the first walk-thru., providing that they are received by the judges in time to do so. Printed maps will NOT be handed out to exhibitors.** Please bring a phone or tablet that you can use to access the online maps, or that can take a photo of the posted maps.

**Set-up:** Friday –We CANNOT enter the Building until 11:30 AM. **Saturday and Sunday** - Site is open 6:30 a.m.

**Measuring** will be done throughout each day based on VMO availability.

**Workers** - Please check in with the volunteer coordinator 10 minutes prior to the start of the class you will be working. See schedule for approximate start times.

**SITE WILL BE CLOSED AND LOCKED within 1 hour after the last run each day. No access to the building after closing-no exceptions. The club is subject to a fee of \$120.00 per hour after the trial hours.**

**DIRECTIONS TO SHOW –**

**From 322 headed West:** Follow 322 towards Commodore Barry Bridge, take last exit for US-130 South. Look for Park entrance 1 mile on right.

**From Philadelphia:** Follow I-95 South to Commodore Barry Bridge. Cross the bridge and take first exit for US-130 South. Look for Park entrance 1 mile on right.

**From the South:** 295 North over Del. Memorial Bridge. Continue on 295 North toward Trenton for 11 miles. Take Exit 10, Center Square Road Turn left and go approx. 1.5 miles Turn right on 130 North approx. 1 mile. Look for park entrance on the left at the High Hill Road intersection.

**From the North:** 295 South towards Delaware Memorial Bridge to exit #13 for US-130 and Commodore Barry Bridge. Continue on US-130 past the Route 322 exit and look for Park entrance 1 mile on right.

## TRIAL SITE RULES

- **NO OUTSIDE FOOD ALLOWED AT DREAM PARK! There is a food vendor on site EXCEPT ON FRIDAY!!**
- **NO DOGS ALLOWED TO "POTTY" IN OR ON THE BUILDING.** Failure to observe this rule is subject to a bench hearing and immediate excusal from the trial for the balance of the trial days.
- **No x-pens in crating area unless approved by the trial chair.**
- **All dogs must be on leash except when competing.**
- **No exhibitors allowed in the restricted private horse boarding / Polo Barns area – please read the posted signs.**
- **SITE WILL BE CLOSED within 60 minutes** after the last run each day. **No admittance to the site after that time**
- **PARKING:** Loading and unloading **ONLY** in front of the main entrance. **Do not leave your vehicle unattended in the loading and unloading area. No Parking in this area.** All vehicles, trailers, vans, and RV's must be parked in designated areas; Vehicles not in compliance with parking rules will be towed away at the owner's expense. **Fire Marshals** require that no vehicle may be parked within **(75) feet of any building, pavilion, or tent, or in roadways** surrounding such, in order for emergency vehicles to have access at all times.
- **Limited Handicapped car/van parking** please arrive early to obtain a spot.
- **Township rule: Unleashed animals** will be subject to capture and/or fine and removal from Dream Park by Logan Township or Gloucester County Animal control. Fine is \$50 per occurrence
- **Please be considerate of the public restrooms.** Trash cans are placed there for proper disposal of paper products.
- **SORRY – DOGS ARE NOT ALLOWED IN ANY RESTROOM AT ANY TIME. PLEASE CRATE YOUR DOG OR HAVE SOMEONE HOLD IT FOR YOU WHILE USING THE RESTROOM.**
- **You are responsible to clean up after your dog.** PLEASE carry the appropriate supplies and keep the trial site clean.
- **Hotels:** Dogs should not be left unattended in the hotel. Reports of barking dogs left unattended in the hotel OR OTHER BEHAVIOR DEEMED INAPPROPRIATE BY THE HOTEL MANAGEMENT MAY be subject to a bench hearing. You must clean up after your dogs at the hotel.
- At the time of this confirmation there are no mask requirements at Dream Park. This may change at any time at which point exhibitors will be notified. Refunds will not be issued if you choose not to attend based on last minute changes to this rule.

You can also **run at the end of the earlier height group or at the beginning of your height group** if that helps ease your conflict. **We do realize that handlers with multiple dogs will have some conflicts.** Conflicts can ONLY be marked in ex/mas classes unless you are running multiple dogs in that class. ALL classes that have 1 walk thru take precedence. If you need assistance with a potential conflict please ask. We would rather assist early than have anyone angry or panicked while ring side. **This is a game and we should all be having fun with our dogs!**
