



## Trial site rules & information:

- **Course map procedures — PLEASE READ:** Per AKC rules as of 10/1/2021, course maps **WILL NOT** be available until the day of the trial. Fast Times will no longer email course maps to exhibitors. Course maps will be posted on site. Maps will also be posted on Fast Times website **the day of the trial before the start of the first walk-thru**. **Printed maps will NOT be handed out to exhibitors**. Please bring a phone or tablet that you can use to access the online maps, or that can take a photo of the posted maps.
- There will not be a food vendor on site. Snacks and water will be provided for workers. Come prepared.
- We will allow a crate to be brought into the building if you have multiple dogs running in the same height, but it must be removed after your runs. No chairs will be allowed in the arena.
- There are no Covid restrictions at the time of this confirmation. The facility will continue to follow NJ recommendations regarding Covid so this rule could change prior to the trial at which time exhibitors would be notified. Refunds will not be given if you choose not to attend.
- Parking will be on both the grass area near the arena and on the gravel. Please follow instructions from club members who will help you park. No RVs
- There will be 1 Porta-potty & hand sanitizer.
- No parking near the red barn with the horses. That area will be coned off.
- Dog potty area is anywhere on the parking side of the property but **NEVER ON THE BUILDINGS!**

**Please note: ALL times after the first walk-thru are approximate – DO NOT wait and arrive close to the time listed.** We are not responsible if you show up late because you thought the class would not start until the times shown below. Please remember that by mid-day – the times may be as much as ¾-1 ¼ hours off.

This is a preliminary judging schedule which is contingent upon the move-up of entries that may not have been received yet. Final numbers may differ.
