**Bitches in season refunds:** For AKC events, Bitches in season are not eligible to participate in obedience or rally trials. Entry fees will be refunded less a \$5.00 processing fee. To receive a refund, **NOTIFICATION MUST** be emailed to Fast Times **PRIOR TO THE START OF JUDGING** on the day in which the bitch is entered. Written verification from a veterinarian is also **REQUIRED** & must be RECEIVED with a copy of the dog's final confirmation within 48 hours after the event. **Please scan & email these documents or send them via fax to 888-521-1706.**

### **IMPORTANT EVENT INFO PLEASE READ:**

- Limited indoor crating is available in the training room where the ring is, in addition to a designated area in the agility building. Dogs that are aggressive to passing dogs/people or that continuously bark or cry will not be permitted to crate inside the building. •
- **Tarps/sheets/towels** must be placed under all crates, no exceptions. The buildings will be open Friday, Saturday and Sunday at 7:30 AM. Unentered dogs may be asked to leave. Please provide your own chairs and crates. No ex-pens.
- Masks are optional at the time of this premium. This rule is subject to change at any time. Event mask rules will be listed in the final confirmations.
- **Reminder to all competitors to read their final confirmations for updated COVID rules.** We will be following the latest information and will continue to adapt our policies as needed to stay in compliance. We will not allow persons to eat inside the building. Exceptions are those eating in private offices such as office staff, Trial Chairs, Trial Secretaries, and Judges.
- Attendees should come prepared with their own food, water and other personal needs. Competitors should plan to eat outside or in their cars.
- Please remind all participants to please stay home if they are not feeling well or have any symptoms whatsoever.
- **Dogs must "potty" in designates areas. Anyone not using designates areas to potty their dogs will be excused from the trial for all remaining classes/days and no refund will be given.**

#### **Directions from the North:**

Garden State Parkway to exit 100A towards Freehold. Merge onto 66W, turn right onto Shark River Road. Right turn into Shafto Road.

#### **Directions from the South:**

Garden State Parkway North to exit 100C NJ-66 W towards Freehold. Merge onto 66W Right turn onto Shark River Road, Right turn onto Shafto Road. ***GPS may take you exit 105, but this will put you on the wrong side of the road. To avoid making a U-turn please use exit 100A or 100C***

**From 295:** Take Exit 60 to I-195E to NJ-138E. Take Exit 35B to merge onto NJ-34N toward Matawan. Follow to Shafto Road. Building on Right.
