- **There is a separate turf area available for indoor crating. Please bring a tarp or mat to place under your crates. Dogs that bark continuously or are aggressive to passing dogs or people will not be permitted to be crated inside.**
- **We are running this trial in GROUPS to facilitate working. We have put a 5 minute break in between groups and will hold to this so that you have time to work classes and still take care of yourself and your dogs. Thank you in advance for volunteering so this trial runs smoothly.**
- **United Dog Agility will be providing the Agility Gate service for this event. Details will be emailed prior to the event.**
- **Course map procedures — PLEASE READ:** Per AKC rules as of 10/1/2021, course maps **WILL NOT** be available until the day of the trial. Fast Times will no longer email course maps to exhibitors. Course maps will be posted on site. Maps will also be posted on Fast Times' website **the day of the trial before the start of the first walk-thru.** **Printed maps will NOT be handed out to exhibitors.** Please bring a phone or tablet that you can use to access the online maps, or that can take a photo of the posted maps.
