There **WILL NOT** be an official measurer at this trial. If the "Will dog need to be measured at this trial?" says yes, you will need to be measured by one of the judges before running. This is for all dogs without a permanent height card or temporary measurement slip. This measurement will only be valid for this trial weekend. The judge will measure dogs before the trial starts and in between classes when available.

VERBAL MOVE-UPS WILL NOT BE ACCEPTED OR PROCESSED. If you are entered in multiple trials, you need to send a separate move-up request for EACH Trial AND EACH DOG.

Again, move-up requests MUST be received by 6 pm the Monday before the event per AKC rules. Day-to-day move-ups must be done onsite and will not be accepted via email. See premium for details.

Course map procedures — PLEASE READ: Per AKC rules as of 10/1/2021, course maps **WILL NOT** be available until the day of the trial. Fast Times will no longer email course maps to exhibitors. Course maps will be posted on site as per AKC rules. Maps will also be posted on the Fast Times website **the day of the trial before the start of the first walk-thru**. **Printed maps will NOT be handed out to exhibitors.** Please bring a phone or tablet that you can use to access the online maps, or that can take a photo of the posted paper maps.

Trial site will be open at 6:30 am Friday for set up.

DIRECTIONS: PLEASE DO NOT COUNT ON YOUR GPS TO FIND THE SITE. Some people have reported that they lose service in some of the surrounding areas. TRIAL SITE RULES

- The trial site is open to exhibitors from 6:30 am each day, until 1 hour after the close of the trial each day.
- Exhibitors failing to clean up after their dogs may be excused from the trial without a refund.
- POND – There is a pond on site, but please keep in mind that standing water may harbor disease-causing organisms. As a safety precaution, please do not allow your dogs to swim in the pond.
- TICKS – The area is farmland and woods. Measures for tick prevention are strongly suggested.
- RVs – There is NO RV parking or camping on site.
- Food – There will be no food. Please plan accordingly.

Please note: ALL the times after the first walkthrough approximate – **DO NOT wait and arrive close to the time listed** Please remember that by mid-day – the times may be off as much as ¾-1 ¼ hours.

This is a preliminary judging schedule which is contingent upon the move-up of entries that may not have been received yet. Final numbers may differ as the chart below is created before the final closing.

These times are only approximations. The Judges, the Club & the Trial Secretary will not be held to anything other than the start times for the first class of each day.
