There WILL be an official measurer at this trial on Saturday & Sunday ONLY. Exhibitor Paul Mount is a VMO and will be measuring dogs Saturday & Sunday. If the "Will dog need to be measured?" says YES, you need to have a valid permanent height card, valid temporary measurement slip or you will need to be measured by the judge Friday or by the VMO on Saturday or Sunday, before running. A measurement done by the judge on Friday is only valid for Friday. If you are also entered on Saturday or Sunday, you will need to be measured again by the VMO before running. **DO NOT RISK A Q – GET MEASURED BEFORE RUNNING.** It is the exhibitor's responsibility to get their dog measured and to know the jump height card rules.

You may request move-ups by emailing them to trialsec@FastTimesAgility.com, via facsimile transmission to 888-521-1706 or in writing by mail to Fast Times at 3 Sherman Ct, Manalapan, NJ 07726. All move ups must be received by 6pm on the Monday preceding the trial. Verbal move-ups will not be accepted or processed. If you are entered in multiple trials, you need to send a separate move-up request for each trial and each dog. **Again, move-up requests MUST be received in writing via email/mail by 6 pm the Monday before the event per AKC rules. Day-to-day move-ups must be done onsite and will not be accepted via email. See premium for details.**

Course map procedures — PLEASE READ: Per AKC rules as of 10/1/2021, course maps **WILL NOT** be available until the day of the trial. Fast Times will no longer email course maps to exhibitors. Course maps will be posted on site. Maps will also be posted on Fast Times' website **the day of the trial before the start of the first walk-thru. Printed maps will NOT be handed out to exhibitors.** Please bring a phone or tablet that you can use to access the online maps, or that can take a photo of the posted maps.

No set up until Friday morning. The site will open each day at 7am.

Measuring: Will be done throughout the day based on judge availability.

Workers please check-in at ringside prior to the start of the class you are scheduled to work!

DIRECTIONS TO SHOW: Bayshore Companion Dog Club, 2962 Shafto Road, Tinton Falls, NJ 07724

(Shafto Road is also known as County Road 547)

From North or South on Garden State Parkway: Exit 100 to Route 33 Westbound. If Northbound, you will at first be on NJ-66 which merges with 33. At first light, turn right onto Shafto Road. Proceed for 1.9 miles. Be careful not to miss the turn - site is inset from the road and view somewhat covered by trees - **because a left turn from Shafto Road to the facility is not allowed.**

From the West: NJ-33 East (through the Traffic Circle with NJ-34, taking the third exit). Continue to the first traffic light – get into the left lane. Proceed North 1.9 miles as described above.

PARKING:

- Dogs are required to be on leash at all times on the property other than during actual competition or at the warmup jump(s).
 - Violators will also be asked to leave for the balance of the trial weekend with no refund of entries.
