If the “Will dog need to be measured?” says YES, you will need to have a valid permanent height card, valid temporary measurement slip, or you will need to be measured by a VMO. **DO NOT RISK A Q – GET MEASURED BEFORE RUNNING.** It is the exhibitor’s responsibility to get their dog measured and to know the jump height card rules. AKC will check this data and you will lose a Q if you do not get measured. We have been told the AKC is cracking down on this.

Trial site information

Property: The property is owned by Premier Office Solutions and its sign as well as Y2K9s will be visible on Davisville Rd. The entrance for the trial is at the rear of the building at the far end of the parking lot. Please park only in the parking lot at the rear of the building.

Building: Building opens at 6:30 am both days. Please do not enter the building prior to this time. The building will be temperature controlled to approximately 70 degrees. Please dress accordingly.

Potty Area: Please do not potty your dog anywhere near the walkway or entrance to the building. The potty area is to the left as you exit the building and is well marked. You are expected to pick up after your dog. Please do not potty your dog at other location.

Dog accidents on the turf are a \$10 potty fine... although we'd rather just avoid these so please make sure your dog is emptied before you enter the building and take them out often during the day.

Restrooms: Indoor bathrooms are on site and marked. Please, no dogs in the bathrooms.

Food: Food will not be sold at this trial. There are many places within a short driving distance to get food. Snacks and water will be available for workers so be sure to volunteer where you can.

Measuring: Will be done throughout the day based on VMO availability.

Worker check-in: volunteers please check in with the worker coordinator 10 minutes prior to the start of the classes you will be working. See schedule for start times.

Additional info:

- **If you are not feeling well, please stay home!**
 - Indoor crating is allowed but please conserve space. We ask that you please stack crates when possible. Chairs are allowed in the crating area unless we run out of space for dogs that need to be brought inside out of the heat.
 - We have scheduled classes as to hopefully get everyone in and out so that no one is on site too long. If you have multiple dogs competing at multiple levels, this is unavoidable.
 - A hose will be available to cool down dogs.
 - **Course map procedures — PLEASE READ:** Per AKC rules as of 10/1/2021, course maps WILL NOT be available until the day of the trial. Course maps will be posted on site. Maps will also be posted on the Fast Times website the day of the trial before the start of the first walk-thru. Printed maps will NOT be handed out to exhibitors. Please bring a phone or tablet that you can use to access the online maps, or that can take a photo of the posted maps. Maps will be posted under the "Agility Maps" tab for all trials.
