

TRIAL SITE RULES & INFO

- At the time of this confirmation, masks and temperature checks are not required by the Horse Park. This is subject to change. Notice will be sent to exhibitors IF this changes prior to the trial. Refunds will not be issued if you decide not to attend.
- **Course map procedures — PLEASE READ:** Per AKC rules as of 10/1/2021, course maps WILL NOT be available until the day of the trial. Course maps will be posted on site. Maps will also be posted on the Fast Times website the day of the trial before the start of the first walk-thru. Printed maps will NOT be handed out to exhibitors. Please bring a phone or tablet that you can use to access the online maps, or that can take a photo of the posted maps. Maps will be posted under the "Agility Maps" tab for all trials.
- There is plenty of space inside the NJ Horse Park facility.
- Per AKC, leashes may be carried on your person while running your dog, either in your pocket or looped over your body or tied around your waist. Those leashes not carried by the handler will be moved by a volunteer leash runner.
- Chairs will be allowed in the crating area.
- **WORKERS ONLY WILL BE ALLOWED TO SET UP THURSDAY NIGHT. EXHIBITORS CAN SETUP FRIDAY MORNING.**
- Site is open each day by 6:30 a.m.
- **Measuring:** Measuring of dogs is always done throughout the day based on judge availability.
- **Worker check-in:** volunteers please check in with the worker coordinator 10 minutes prior to the start of the classes you will be working. See schedule for start times
- **CRATING:** There will be crating allowed inside the facility in a designated area. Please see additional information below for more details.

PARKING:

- There is ample parking on grass adjacent to the arena – please don't park on the roadway. Please obey posted parking signs.
- Parking is not allowed on the grass between the tree row and the arena – again, please obey posted signs.
- Daytime shade tents are permitted behind your vehicle. Please be considerate of your fellow exhibitors - don't set your tent up or park so that you are blocking someone else. If you are blocking someone, you will be asked to move. There will be a designated tent area if you plan to leave a shade tent overnight. No overnight tent camping is permitted.
- If you plan to work out of your car and leave your engine running, you must park in the designated idling car area to avoid impacting other dogs/tents. If there are any complaints, you WILL be required to move your vehicle.
- Parking at the front entrance to the arena is restricted to club members. Limited handicapped parking spots are available on a first-come, first-serve basis.
- No RV parking in the exhibitor car parking areas: overnight RVs must park in the RV area. Day RVs should discuss parking arrangements with RV coordinator prior to arrival.

CRATING:

- There will be limited crating under cover in the arena. Please be considerate of your fellow exhibitors and conserve space where possible.
- Crate-aggressive dogs should not be crated in a high-traffic area – walkways etc. -- and may be required to move if they exhibit a repeated pattern of crate-guarding.
- Crating is on the same dirt as the rings; we suggest using a tarp to protect your crates and belongings.

POTTING YOUR DOG:

- **PICK UP YOUR POOP!** Anyone observed not picking up after their dog will be asked to leave the trial for the balance of the weekend with no refund of entries.
- Do not allow your dog to potty on anything man-made – the building, trash receptacles, etc. Remember, someone has to handle those things.

OFF-LEASH DOGS:

- Dogs are required to be on leash at all times on the ENTIRE Horse Park property other than during actual competition or at the warmup jump(s).
- Per our contract: Intentional unleashed dogs subject to capture and/or fine and removal from Horse Park by Upper Freehold Twp. Animal Control. There is an additional \$75.00 fine per dog and per occurrence payable to the Horse Park.
- Violators will also be asked to leave for the balance of the trial weekend with no refund of entries.

From the NJ Turnpike: Take exit 7A to 195 East. After 5.5 miles take Exit 11 (Cox's Corner/Imlaystown.) As you exit, keep left. Go to the stop sign and make a right onto Route 524. Go 1.4 miles to the entrance of the Horse Park on the left.

From the Garden State Parkway: Take exit 98 to Route 195 and go west to exit 11. As you exit, keep to the right. Go to the stop sign and make a right onto Route 524. Go 1.4 miles to the entrance of the Horse Park on the left.
