There **WILL NOT** be an official measurer at this trial. If the "Will dog need to be measured?" says YES, you will need to have a valid permanent height card, valid temporary measurement slip, or you will need to be measured by the judge before running. This measurement will only be valid for this 3 day event. DO NOT RISK A Q – GET MEASURED BEFORE RUNNING. It is the exhibitor's responsibility to get their dog measured and to know the jump height card rules. AKC will check this data and you will lose a Q if you do not get measured before your run.

You may request move-ups by emailing them to trialec@FastTimesAgility.com, via facsimile transmission to 888-521-1706 or in writing by mail to Fast Times at 3 Sherman Ct, Manalapan, NJ 07726. All move ups must be received by 6pm on the Monday preceding the trial per AKC rules. VERBAL MOVE-UPS WILL NOT BE ACCEPTED OR PROCESSED. If you are entered in multiple trials, you need to send a separate move-up request for EACH Trial AND EACH DOG. Again, move-up requests **MUST** be received in writing via email/mail by 6 pm the Monday before the event. Day-to-day move-ups must be done onsite and will not be accepted via email. See premium for details.

Course map procedures — PLEASE READ: Per AKC rules as of 10/1/2021, course maps **WILL NOT** be available until the day of the trial. Course maps will be posted on site. Maps will also be posted on the Fast Times website the day of the trial before the start of the first walk-thru. Printed maps will NOT be handed out to exhibitors. Please bring a phone or tablet that you can use to access the online maps, or that can take a photo of the posted maps. **Maps will be posted under the "Agility Maps" tab for all trials.**

SET-UP: Exhibitors can set up between 3-5 PM on Thursday. The site will open at 6:30 AM Friday, Saturday & Sunday.

DIRECTIONS TO SHOW:

From the NYS Thruway (North or South): Exit 16 - Merge onto NY- 17 W Take exit 122 - Crystal Run Crossing. Turn right onto Crystal Run Crossing. Turn left onto Crystal Run Road. Take to end - make right at stop sign - County Rd 83/ Goshen Turnpike/ Scotchtown Ave. Approximately 1.2 miles to Tetz Lane. Left onto Tetz Lane to end.

From the West: I-84 Eastbound – Take Exit 19A for NY-17 E towards New York City. Keep Right for County Rd 67/Crystal Run Rd. At traffic light, turn Left onto Crystal Run Rd, follow for 2 miles, turn Right at Stop Sign onto Goshen Turnpike/Scotchtown Ave. After 1.2 miles, turn Left onto Tetz Lane. Follow to end.

From the East: I-84 Westbound – Take Exit 19A to merge onto NY-17 towards New York City. Take Exit 122 for County Rd 67/Crystal Run Rd. At traffic light, turn Left onto Crystal Run Rd, follow for 2 miles, turn Right at Stop Sign onto Goshen Turnpike/Scotchtown Ave. After 1.2 miles, turn Left onto Tetz Lane. Follow to end.

TRIAL SITE RULES & INFORMATION

- **5 mph speed limit on the property. Violators may be asked to leave without a refund.** Tetz Lane is posted 30mph. It is strongly suggested that you go no faster than 10mph between the white house on the turn and the first red barn.
- Refer to site map below. Park only in designated areas as shown in the site map below or as directed by trial officials. Do not block RVs.
- Please stay close to the barn! The fields, areas by the houses, the horse paddock area, and fenced runs in front of the building are all off limits.
- Crating is not permitted in the seating area of the arena. Non-members may crate in empty stalls and /or crates as available and bring in their own crates as needed to place in stalls. Skyline members request that you do not use any crates that have bedding in them. It is also very convenient to work from your vehicle, and there is plenty of room to tent/crate outside in designated areas.
- During trial hours, dogs must be on leash at all times when not competing in the arena or at the practice jump. No flexi leashes in extension allowed in the barn or arena.
- No food or treats are to be left in the stalls or the arena overnight.
- No personal heaters of any kind (propane, kerosene, electric ets.) allowed in stalls, in any building or within 100 feet of any building.
- No smoking in any building or within 50 feet of any building. Cigarette butts must be properly disposed of.
- All trash is to be placed in proper receptacles, black/ garbage and blue/ recycling.
- Clean up after your dog. The orange poop cans with bags are located outside.
- Unsupervised children are not allowed on or about the premises.
- The consumption of alcoholic beverages is prohibited during trial hours.
- Self-contained RVs only / Limited number / Pre-registration required.

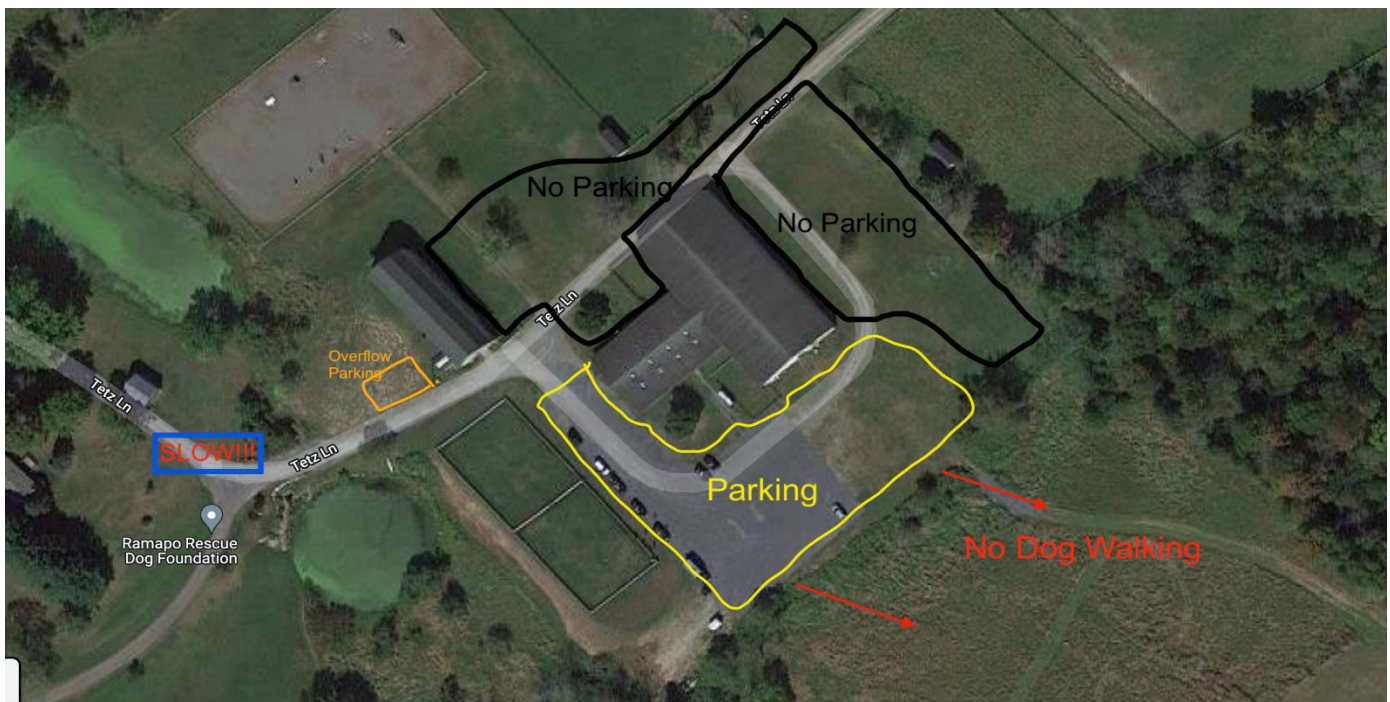
