DIRECTIONS TO SHOW

From the North: (Northern New Jersey/New York/Wilkes Barre/Scranton) Interstate 78 West to Interstate 81 South to Exit 29a Route 934 South to Route 322 West to Route 117 North. Turn right on Airport Road.**

From the South: (Baltimore/York) Interstate 83 North to Route 322 At Harrisburg to Route 322 East to Route 117 North. Turn right on Airport Road.**

From the East: (Southern New Jersey/Philadelphia/Reading) Pennsylvania Turnpike (Interstate 76) West to Exit 266 to Route 72 North to Route 322 West to Route 117 North. Turn right on Airport Road.**

From the West: (Ohio/Pittsburgh/Carlisle) Pennsylvania Turnpike (Interstate 76) East to Exit 266 to Route 322 West to Route 117 North. Turn right on Airport Road.**
