



### **Trial site rules and information:**

- There is a separate turf area available for indoor crating. Please bring a tarp or mat to place under your crates. Dogs that bark continuously or are aggressive to passing dogs or people will not be permitted to be crated inside.
- **Course map:** Course maps will be posted on site, per AKC rules. Maps will also be posted on the Fast Times website under the “Agility Maps” tab prior to the first walk (provided we receive them from the judge). Printed maps will NOT be available for exhibitors.
- **NO SETUP UNTIL SATURDAY MORNING!** The site will open 1 hour before the first walk each day.
- **Food:** There will not be food available for sale on site. Please come prepared. There are many places within a short driving distance to get food.
- **Worker check-in:** volunteers, please check in with the worker coordinator 10 minutes prior to the start of the classes you will be working. See schedule for start times.

**Please note: ALL times after the first walk-thru are approximate – DO NOT wait and arrive close to the time listed** We are not responsible if you show up late because you thought the class would not start until the times shown below. Please remember that by mid-day – the times may be as much as ¾-1 ¼ hours off. **This is a preliminary judging schedule which is contingent upon the move-up of entries that have not been received yet. Final numbers may differ.**

**These times are only approximations. The Judges, the Club & the Trial Secretary will not be held to anything other than the start times for the first class of each day.**
