The judge will be available to measure starting at 7:15 an and then in between classes as needed. Be sure to give yourself plenty of time so you are not rushed and don't miss your walkthrough.

DIRECTIONS TO SHOW – Our red indoor arena can be seen from the road

Coming from 295 take exit #72 route # 31 north/Pennington. Go 4 miles to Gulf gas station, bare right on route #654 towards Hopewell. Go 3 miles to the second light and make a left onto N. Greenwood Av. (which turns into Rileyville rd/ Hopewell-Wertsville rd). Go about 3 miles and 290 Rileyville rd will be on the left. **GO PAST** the Farm entrance to the 3rd driveway on the left. Red indoor arena can be seen from the road.

Coming from 202N take Wertsville rd exit. Follow Wertsville rd aprox 3 miles to Hopewell-Wertsville rd (Rileyville rd) on Right. Go aprox 1/2 mile, past Saddle Shop rd on right to next driveway on right. Red indoor arena can be seen from the road.

From 202S take the jug handle. Follow Wertsville rd aprox 3 miles to Hopewell-Wertsville rd (Rileyville rd) on Right. Go aprox 1/2 mile, past Saddle Shop rd on the right to the next driveway on right. Red indoor arena can be seen from the road.

TRIAL SITE INFO:

- Dogs are not allowed to be exercised past the building, in the paddocks with horses, or near the kennel. There are plenty of places to walk dogs in front of the building.
- **NO INDOOR CRATING AT THIS EVENT!!! Be sure to come prepared to work from your car.**
- NO DOGS ALLOWED TO "POTTY" IN THE BUILDING
- NO DOGS OFF LEASH INSIDE OR OUTSIDE except in the ring or practice jump areas.
- Exhibitors are to work out of their cars. No indoor crating will be allowed. Please come prepared. Only exhibitors will be allowed into the building.
- No food vendor at this trial.
- **Course map procedures — PLEASE READ:** Per AKC rules as of 10/1/2021, course maps **WILL NOT** be available until the day of the trial. Fast Times will no longer email course maps to exhibitors. Course maps will be posted on site. Maps will also be posted on Fast Times website **the day of the trial before the start of the first walk-thru**. **Printed maps will NOT be handed out to exhibitors**. Please bring a phone or tablet that you can use to access the online maps, or that can take a photo of the posted maps. **Maps will be posted under the "Agility Maps" tab for all trials.**
- NO RV PARKING
- Limited Handicapped car/van parking please arrive early to obtain a spot.
- YOU ARE RESPONSIBLE TO CLEAN UP AFTER YOUR DOG. Please carry the appropriate supplies and keep the trial site clean.
- Hotels: Dogs should not be left unattended in the hotel. Reports of barking dogs left unattended in the hotel OR OTHER BEHAVIOR DEEMED INAPPROPRIATE BY THE HOTEL MANAGEMENT MAY be subject to a bench hearing. You must clean up after your dogs at the hotel. Please remember that the hotels is considered an extension of the trial site by AKC and as such can be subject to Event Committee hearings.
