Please read ALL of the following trial rules/info:

- DO NOT speak to facility staff regarding issues with the facility. Take all concerns directly to the club.
- **No brushing or grooming of dogs anywhere in the building.**
- No food or drinks on the turf around the rings or in the crating area (except water).
- From the parking lot, we will be allowed to use the door by the Standard ring to enter and exit. The garage door will be closed shortly after the equipment is unloaded Saturday morning.
- Dogs are to be pottied in the grass area out the door by the jumpers ring or in the grass between the parking lot and Wawa **NOT IN THE GRASS BY THE DOOR!!!**
- **ALL OTHER AREAS ARE OFF LIMITS FOR WALKING DOGS!** Anyone found walking dogs outside the designated area will be asked to leave the trial site and told not to return! Remember to clean up after your dogs! There are cameras and we will be watching. Anyone found not cleaning up after their dogs will be asked to leave the trial site.
- No RV parking allowed on site.
- **WAWA WILL BE CLOSED FOR REMODELING DURING THIS EVENT!** The facility sells "snack stand" type food.
- All dogs must be on leash except in the ring and in the warmup area.
- All crates must be placed on a waterproof mat or tarp.
- **Crating may be tight! Stack crates whenever possible. We are asking everyone to conserve space. Chairs may not be allowed in the crating area if additional space is needed for dogs.**
- No chairs on turf around the rings blocking the flow of traffic. If it gets too congested, we will ask all chairs to be removed.
- Course maps will be posted on site. Maps will also be posted on the Fast Times website the day of the trial before the start of the first walk-thru. Printed maps will NOT be handed out to exhibitors. Maps will be posted under the "Agility Maps" tab for all trials.
- **NO SETUP UNTIL Saturday morning!** Site opens @ 6:30 am each day.
- **Measuring:** Measuring will be done throughout the day based on judge availability as needed.
- **Worker check-in:** please check in with the worker coordinator 10 minutes prior to the start of the classes you will be working. See schedule for start times.

ROUTES TO SHOW:

New Jersey Turnpike Exit 8 to Rt. 33 East

1. From points east – Take Route 33 west to Woodward Rd. Turn right on Woodward Road. MSK is located on the right, next to Wawa.

Route 9 to 33 West

2. From points west - Take Route 33 east to Woodward Rd. Turn left on Woodward Road. MSK is located on the right, next to Wawa.

Please note: ALL the times after the first walk-thru are approximate – DO NOT wait and arrive close to the time listed.

Please remember that by mid-day – the times may be as much as ¾-1 ¼ hours off.
