- **There is a separate turf area available for indoor crating. Please bring a tarp or mat to place under your crates. Dogs that bark continuously or are aggressive to passing dogs or people will not be permitted to be crated inside.**
- **We are running this trial in GROUPS to facilitate working. We have put a break in between groups and will hold to this so that you have time to work classes and still take care of yourself and your dogs. Thank you in advance for volunteering so this trial runs smoothly.**
