



## **Trial site and club rules and information:**

There is a separate turf area available for indoor crating. Please bring a tarp or mat to place under your crates. Dogs that bark continuously or are aggressive to passing dogs or people will not be permitted to be crated inside.

- **Course map procedures — PLEASE READ:** Per AKC rules as of 10/1/2021, course maps WILL NOT be available until the day of the trial. Course maps will be posted on site. Maps will also be posted on the Fast Times website the day of the trial before the start of the first walk-thru. Printed maps will NOT be handed out to exhibitors. Please bring a phone or tablet that you can use to access the online maps, or that can take a photo of the posted maps. Maps will be posted under the “Agility Maps” tab for all trials.
  - **NO SET-UP UNTIL SATURDAY MORNING**
  - **SITE OPENS EACH DAY @ 6:30 AM.**
  - **Food:** There will not be food for sale on site, but the club provides plenty of food for anyone who works!
  - **Measuring:** The judge will measure dogs before the trial starts and between classes as needed.
  - **Worker check-in:** volunteers, please check in with the worker coordinator 10 minutes prior to the start of the classes you will be working. See schedule for estimated start times.
