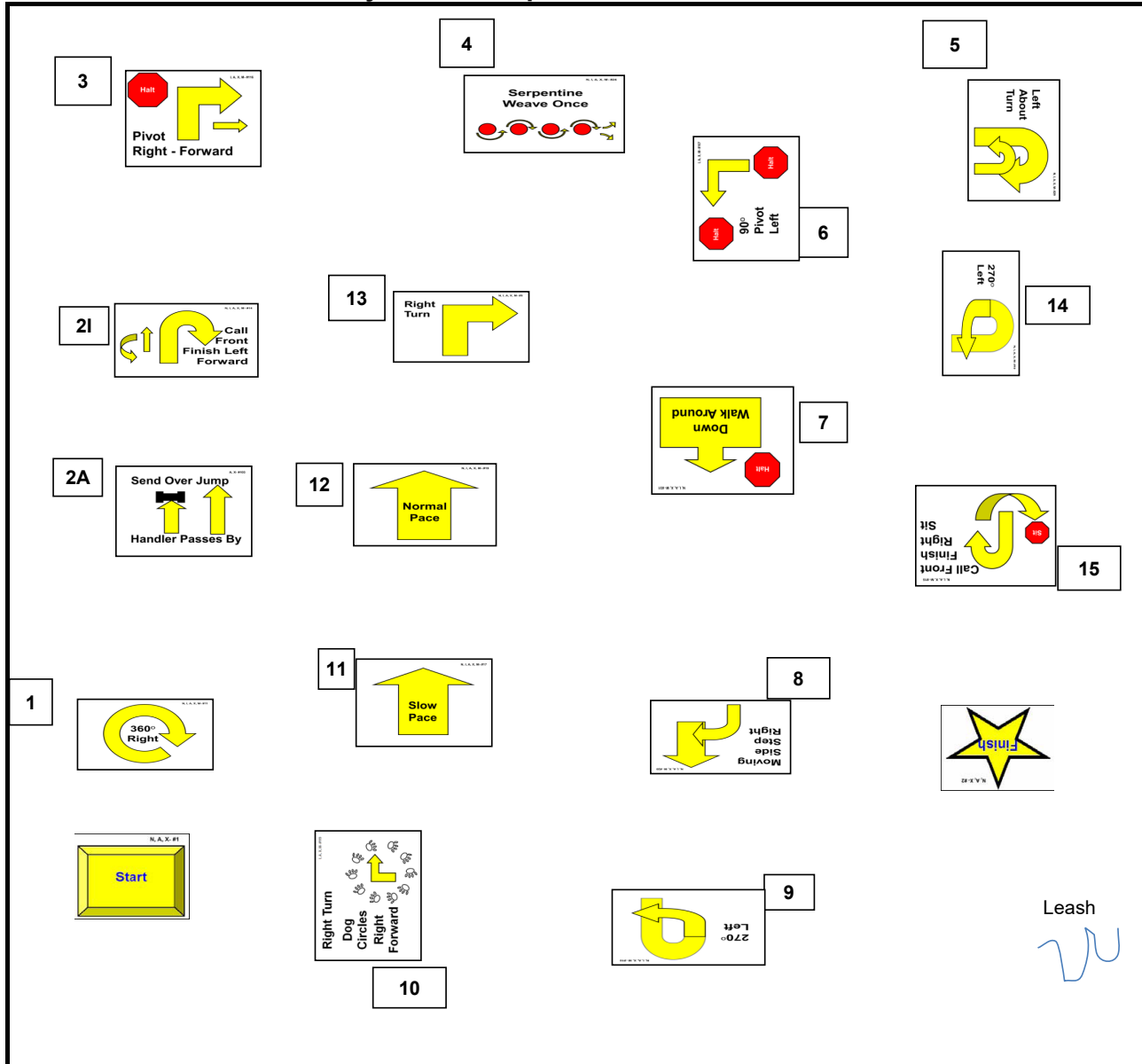

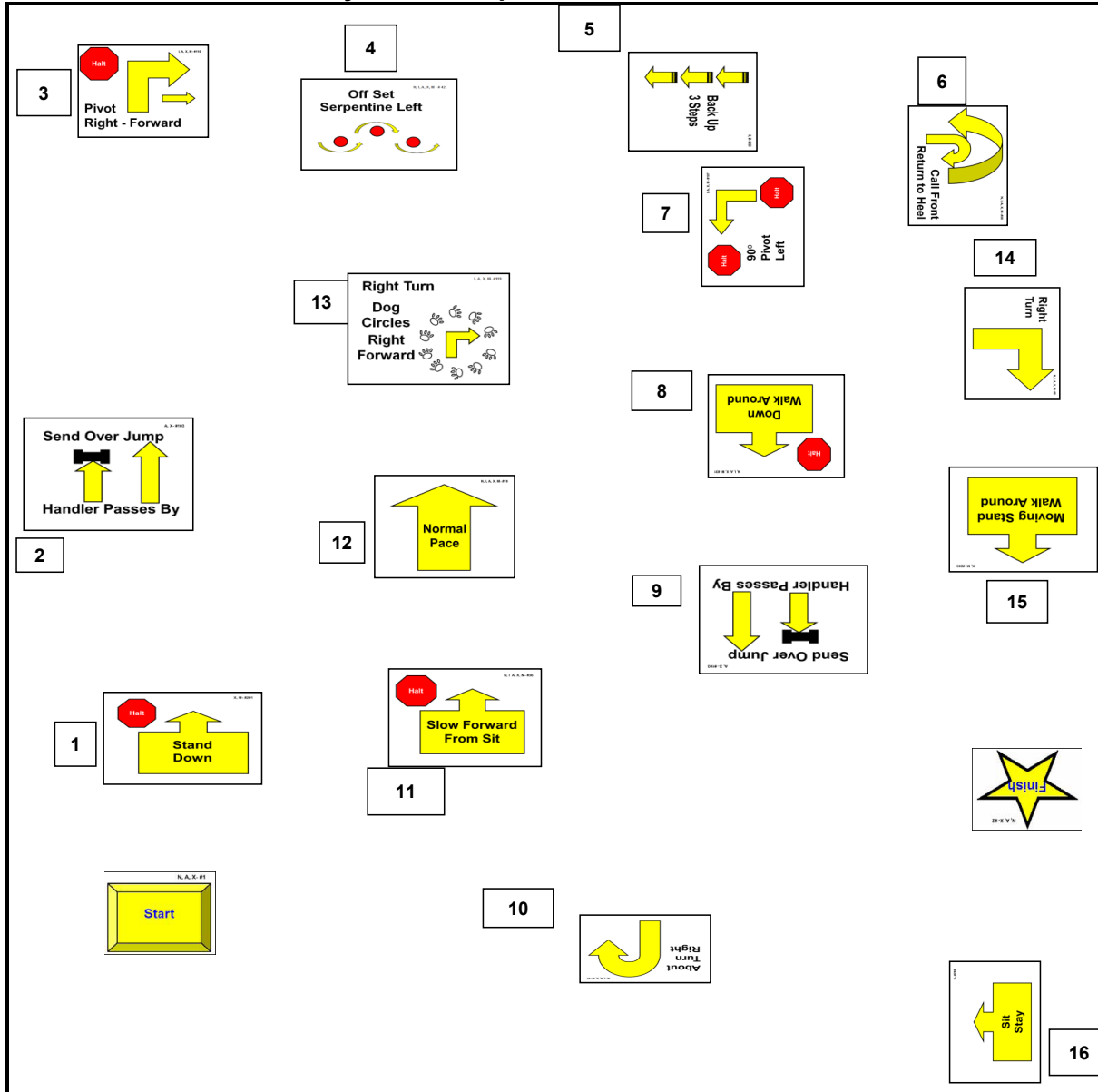

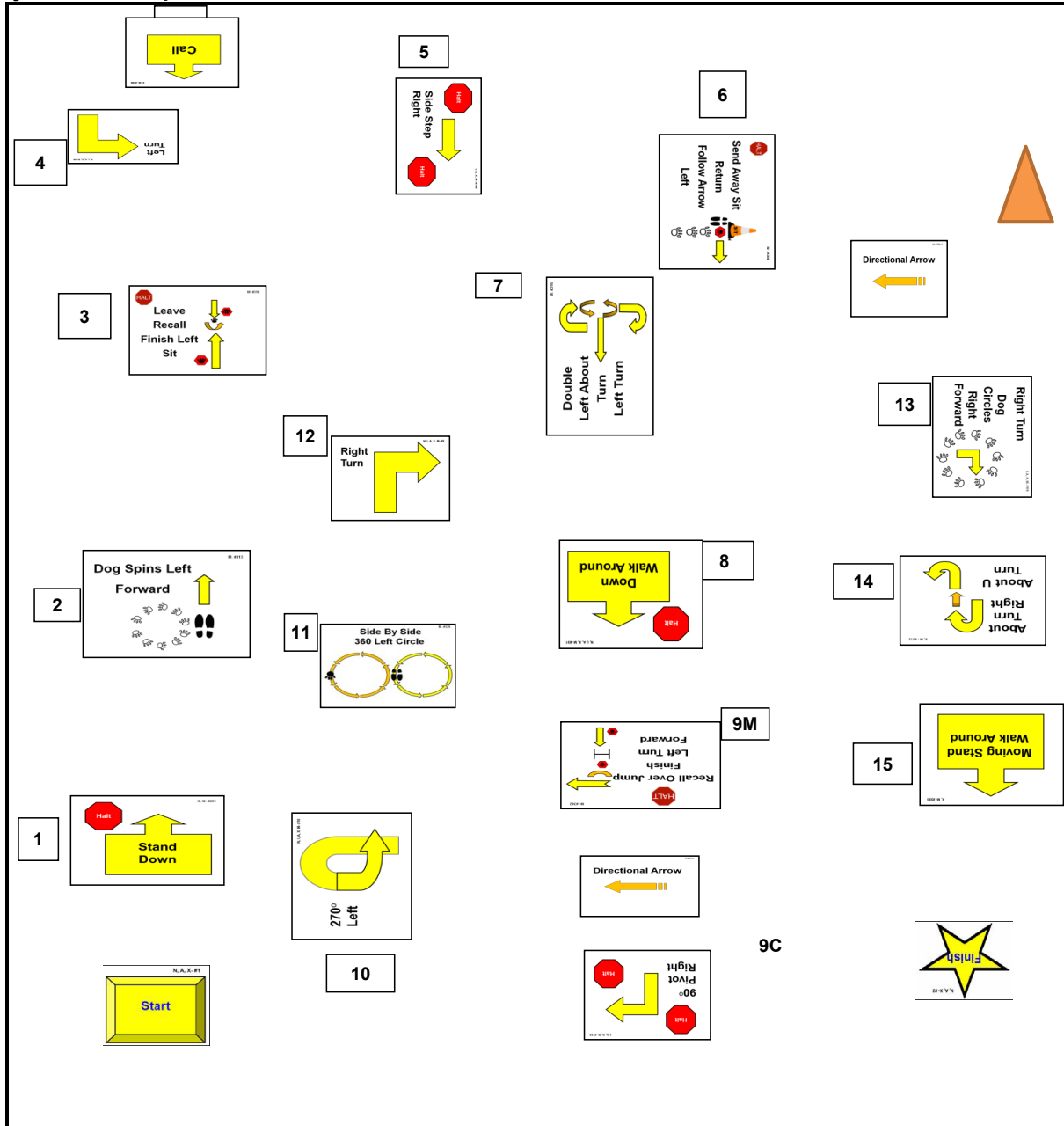

- 10 ABOUT TURN RIGHT #7
- 11 Slow Forward from Sit #36
- 12 NORMAL PACE #19
- 13 Right Turn Dog Circles Right Forward #119
- 14 Right turn #5
- 15 Moving Stand Walk Around #203 **S**

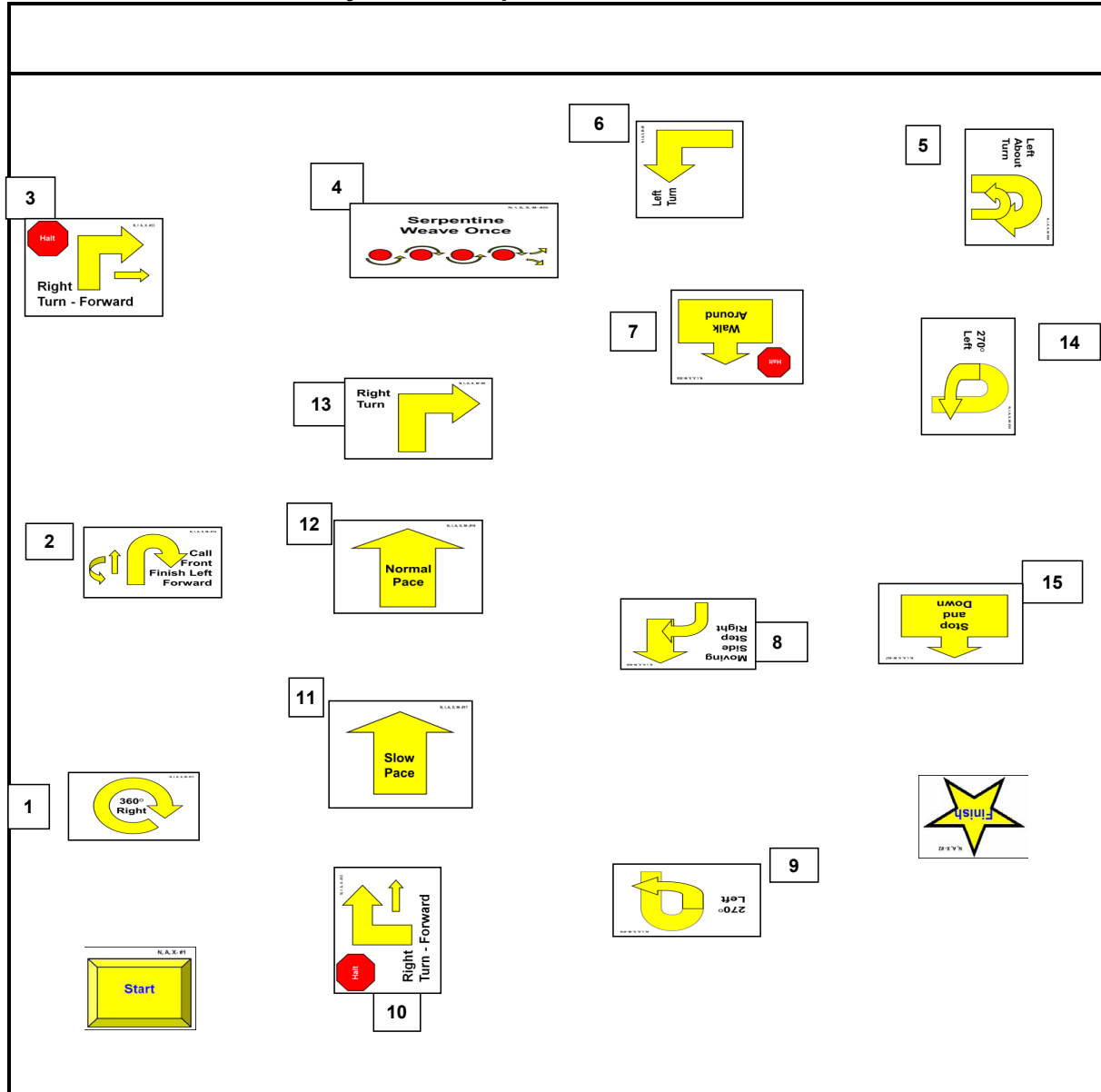
