EXHIBITOR ADMISSION

Exhibitors will receive a total of 2 admission tickets—one <u>for yourself</u> and 1 additional ticket for your assistant. Exhibitors and assistants will be seated to watch the Championship Round on a first-come basis and must request a wristband from the trial secretary. There will be a limit of 130 seats available.

CRATING AREA

The crating area is sufficient for all dogs entered. Please note that benches will be utilized this year. There will not be space available for unentered dogs. No private Ex-pens will be allowed in the crating area due to NYC fire regulations. Soft crates are permitted but not recommended. Dog tents are not allowed. Please do not leave personal items unattended in the crating area, as it will be open to the public. Quiet crating will be offered for 50 dogs. These 50 spots will be chosen at random (by handler) from those that make the request on their entry forms.

If entering through the Fast Times online entry system, payment must be made via PayPal.

ENTRY FEE: \$100 PER DOG. (Includes a \$3.50 AKC recording fee for each run.)

- 1. Dogs must have a MACH or a PACH title at the time the entry is received in order for the entry to be valid for this trial. To enter in Preferred, the dog must have a PACH title at the time of entry. To enter in Regular, the dog must have a MACH title at the time of entry.
- 2. There is a limit of 4 entries per owner/handler.
- 3. Entries delivered to any address other than the address listed in this premium list are considered invalid entries. They will not be processed and will be returned to the sender.
- 4. All dogs jumping in the regular class level must jump in their true measured jump height. There is no 24C jump height offered. You cannot enter 2 different jump heights or one Regular class and one Preferred class at this trial.

Random Draw information for 2026...PLEASE READ!!!

This trial is limited to 600 runs. The Championship round is not included in this trial's run limit.

Entries Received Before the opening date/time will not be accepted. Entries delivered by overnight mail must indicate no signature required. Random draw closes Monday, December 15, 2025 @ 6 PM.

- 1) You can only send 1 dog's entry in a single postmarked envelope. This includes larger, overnight envelopes.
- 2) A completed entry form with complete payment must be received during the draw period. Entries can be sent via postal carrier or you may enter online through the Fast Times online entry system w/payment made via PayPal.
- 3) Overnighting entries <u>DO NOT</u> provide an advantage since entries will be selected via Random Draw. All valid entries received during the Draw Period will be included in the Random Draw and will be treated equally without regard to the date received or any other criteria.
- 4) A check or money order <u>made payable to Fast Times, Inc</u>. MUST be received with any mailed paper entry, or the entry will be considered invalid per AKC rules and will not be included in the Random Draw.
- 5) Electronic payment through PayPal MUST be made if entering through the Fast Times online entry system. PayPal fees are nonrefundable and are the exhibitor's responsibility when using the online entry option.
- 6) Each entry received will receive a separate "draw" position.
- 7) We will be using an impartial computer randomizer to draw a list of random dogs to fill this trial. Once the trial limit has been reached, the next 50 dogs, in the order they were drawn, will be added to a waitlist. Any entries beyond those entered and those added to the waitlist will be closed out.
- 8) Duplicate entries will not be refunded! Sending multiple entries for the same dog does not increase your chances of getting into this trial. Each dog will only receive one slot in the draw.
- 9) A maximum of 35 entries will be reserved as permitted with this method of accepting entries. This includes the 2025 Purina Pro Plan Incredible Dog Challenge National Finals dog agility winners, the past 5 Westminster Masters Agility Champions, and the US JR EO Team. These dogs will receive an invitation to this trial. Title requirements do not apply to these invitees. Invitee entries must be received by Fast Times, Inc. before the opening date of Monday, November 24, 2025, at 7:00 am EST.

Wait List statements:

Westminster Kennel Club is offering a wait list to fill openings created by withdrawn entries after the trial's closing on Monday, December 29, 2025, at 6:00 PM EST. A maximum of 50 entries will be placed on the waitlist.

- Entries withdrawn **BEFORE** the trial closes on Monday, December 29, 2025, at 6:00 PM EST will receive a full refund (subject to a \$5 processing fee & nonrefundable PayPal fees).
- Entries withdrawn AFTER the trial closes on Monday, December 29, 2025, at 6:00 PM EST but <u>prior to</u>
 Monday, January 12, 2026, at 3:00 PM EST
 will be replaced with an entry from the waitlist <u>if one is available</u>.
 Any withdrawn entry replaced by an entry from the waitlist will receive a refund minus a \$5.00 processing fee & any nonrefundable PayPal fees.
- Any wait-listed entry not moved off the waitlist and into the trial by January 20, 2025, at 3:00 PM ET will receive a refund of their entry fees (minus any nonrefundable PayPal fees).
- <u>All entries</u>, including wait-listed entries, must be received by Fast Times prior to the trial closing on Monday, December 29, 2025, at 6:00 PM EST.

REFUNDS: There shall be no refunds for entries withdrawn after the closing date except for female dogs in season that provide a vet note as listed below. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, an act of God, public emergency, act of public enemy, or any other cause beyond the control of the event organizing committee. No entry will be refunded in the event a dog is absent, disqualified, or excused from competition by the action of the Trial Committee, regardless of the reason for such absence or dismissal. There is a \$5.00 processing fee for **ALL** refunds. **No refunds will be issued for overpayments of \$10 or less.**

BITCHES IN SEASON are not eligible to participate. Entry fees will be refunded minus a \$5.00 processing fee. Written verification from a veterinarian is required. Notification for refund of bitches in season must be RECEIVED by the trial secretary before the start of the trial. A copy of the Veterinarian's note AND a COPY OF THE DOG'S FINAL CONFIRMATION MUST accompany any such refund request. First Two Rounds (STD & JWW)

- 1. These two rounds will be scored as AKC qualifying runs. Any Q's achieved will count with AKC towards regular agility titles. Jump heights offered 4"-24". There is no 24C class level offered at this trial. Dogs whose measured height at the withers is 22" and under cannot enter the 24" jump height in the 24C class. Dogs may run in the Preferred jump height in both rounds provided they have the required PACH title prior to the trial closing date.
- 2. Judging will begin as early as 7:00 AM. See final confirmation for details.
- 3. Dogs may not run at a height higher than their true measured height in STD and JWW rounds or in the Championship round.
- 4. Dogs may run at their Preferred jump height in STD and JWW rounds, provided they have entered in the Preferred title track and have the required PACH to do so. For purposes of eligibility and placement for the Championship round, dogs running in prefered will be scored and placed within their true jump height group during the re-scoring process. See below for more details.

Requirements and scoring for eligibility into the WKC Championship round. STD and JWW runs will determine eligibility:

- 1. Dogs must Q in one of the first two runs (STD and/or JWW) to be eligible for the Championship round. Elimination (E) or being Absent from either round (STD and/or JWW) will eliminate eligibility for the championship round with a no score. Doing Fix N Go will cause an elimination and result in not being eligible for the championship round.
- 2. Scoring for eligibility to the Championship round will be the combined actual running time of both runs, plus <u>any</u> faults (this includes time faults). The 4 Paw Safety rule will be in effect.
 - a. R, W, T will be assessed 5 points.
 - b. F will be assessed 10 points.
 - c. Course time faults will be 3 points for every full second over the course time.
- 3. After these first two rounds, the data will be re-scored to determine eligibility for the Championship round. Dogs will be placed in order of the lowest combined score within their true AKC jump height.
- 4. All dogs in the regular level will be required to jump at their AKC regulation jump height based on their shoulder height. Any dog needing measurements must be measured before running.
- 5. Dogs that ran in the preferred jump height level in the first two rounds must run at their Preferred jump height in the Championship rounds. There is not a separate Preferred Championship round.
- 6. For purposes of the placement for the Championship round and overall WKC Master Champion, they will be scored and placed within their true jump height group: *

```
4" Pref / 8" Reg - all scored together as true jump height 8" 8" Pref / 12" Reg - all scored together as true jump height 12" 12" Pref / 16" Reg - all scored together as true jump height 16" 16" Pref / 20" Reg - all scored together as true jump height 20" 20" Pref / 24" Reg - all scored together as true jump height 24"
```

- 7. A maximum of 10 dogs from each jump height will be selected for the Championship round.
- 8. In each jump height, the top 3 qualifying dogs, regardless of breed, will be chosen for the Championship round. After that, additional dogs will be chosen by individual breed. One of each breed from the remainder of the qualifying dogs in each jump height will be chosen until the limit is reached. One qualifying Canine Partner will be included in the breeds selected to make up the 10 dogs chosen in each jump height.
- 9. If there are not enough individual breeds to make up the 10 dogs in each jump height, the next dog with the lowest combined score will be included, regardless of breed. This means that more than one dog of any breed may be chosen.

WKC Championship Round Scoring and Awards:

- 1. The Championship course will be a modified Time to Beat style course with a Dog Walk added. The WKC Championship Scoring will be using modified Standard Course rules.
 - a. There will be no Refusals or Runouts (R) called.
 - b. Each Wrong Course (W) will be assessed a 5-point fault.
 - c. Each Failure to Perform (F) will be assessed as a 10-point fault.
 - d. Course Time Faults will be 3 points for every full second over Standard Course Time (SCT).
- 2. There will not be a 26" class in the championship round.
- 3. Each Dog's Championship Round Score will be calculated using the dog's running time <u>plus any</u> <u>course or time faults</u> (please remember there are no refusals scored in this round but there are time faults). Placements within each true jump height will be determined using the championship round score.
- 4. The overall Master Championship Round Score will be calculated by taking the Championship Course Yardage for the dog's true jump height divided by the dog's Championship Round Score (which is calculated using the dog's running time <u>plus any course or time faults.</u>) for the 1st place dogs of each jump height. The highest result will determine the overall WKC Master Champion. For example, if a dog with a Championship Round Score of 39.23 and a Course Yardage of 112 yards then the dog's Master Championship Score would be 2.85.
- 5. The finals will be televised nationally on FOX (date/time TBA). As such, Westminster encourages all exhibitors to dress in clean and presentable attire to present an appropriate image of our sport. No bare feet, please. Our presenting sponsor, Purina Pro Plan, will provide exhibitor shirts.
- 6. FCI exhibitors must be pre-qualified before entering the trial.

 AKC will review FCI titles to determine if they equate to the corresponding US titles. Entry forms must be submitted by December 9, 2025, to give time for verification before the random draw.

Please see the AKC Regulations for Agility Trials for current class descriptions. Dogs must be entered only in Regular Classes or Preferred Classes, with no crossover between them allowed at the same set of trials.

HEIGHT DIVISIONS

Owners/Agents are responsible for entering the proper height divisions. All height divisions will be offered in both the standard classes and the jumpers with weaves classes.

<u>Regular</u> Exhibitors may choose to enter their dog in a higher height division than required by AKC, but not in a height division lower than the AKC-mandated height.

Data Entry and Changes to Your Information

Data entry mistakes happen. That is why we ask everyone to READ their preliminary & final confirmation very carefully. For the majority of entries, dog and owner/handler information remains the same from trial to trial so we ask that you <u>highlight any and all.</u> Examples of changes are:

- new email address
- new titles
- new handler
- new address and phone
- new jump height (including jump height changes from trial to trial)

Please highlight <u>ANY</u> of these changes on your entry forms so we can update this info in our database. We will most likely not pick up these changes from an entry form if they are not highlighted, any you and your dog are already in our database from a previous entry.

****TRIAL REGULATIONS FOR EXHIBITORS***

- **RETURNED CHECKS** do not constitute a valid entry fee. A charge of \$30.00 will be owed for each returned check.
- FAX, TELEPHONE, ONLINE, AND UNSIGNED ENTRIES cannot be accepted.
- ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS OR PHOTOCOPIES OF ENTRY FORMS without the Agreement and Rules attached to the Official AKC Entry Form are NOT ACCEPTABLE.
- ENTRIES RECEIVED WITHOUT FEES will not be accepted.
- NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.
- ACKNOWLEDGEMENT OF ENTRIES will be made as soon as the trial closes or limits are reached. Acknowledgment of entries will
 include confirmation notices.
- **ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Trial Committee. If, because of riots, civil disturbances, or other acts beyond the control of the management, it is impossible to open or complete the match, no refund of entry fees will be made.
- **ERRORS ON ENTRY BLANKS** Owners are responsible for errors in making out entry forms, and no entry fee will be refunded in the event of such errors or cancellation of entries after the trial has closed.
- CONSULT FINAL CONFIRMATION FOR TIME OF JUDGING.
- **JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS.** The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.
- **TRIAL COMMITTEE** will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.
- DOGS This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), AKC Canine Partners listing number (if the trial-giving club is offering the option of Canine Partners entries. See front page of the premium for that information), or approved Foundation Stock Service (FSS) breeds are eligible to participate. All American dogs that have been listed with AKC Canine Partners may participate if the trial-giving club is offering the option of mixed breed entries provided their listing number has been recorded on the entry form. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations, it includes both sexes. Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness that may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four months of age are strictly prohibited from the trial grounds.
- **DOGS MUST ARRIVE** before 7:00 AM; otherwise, they must be available for measuring before their class begins.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running, If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.
