

Trial site information

Property: The property is now owned by Fred Beans. I'm not sure if they have a sign out front, but there is a Y2K9s sign visible on Davisville Rd. The entrance for the trial is at the rear of the building at the far end of the parking lot. Please park only in the parking lot at the rear of the building.

Building: Building opens at 6:30 am both days. Please do not enter the building prior to this time. The building will be temperature controlled to approximately 70 degrees. Please dress accordingly.

Potty Area: Please do not potty your dog anywhere near the walkway or entrance to the building. The potty area is to the left as you exit the building and is well marked. You are expected to pick up after your dog. Please do not potty your dog at other location.

Dog accidents on the turf are a \$10 potty fine... although we'd rather just avoid these so please make sure your dog is emptied before you enter the building and take them out often during the day.

Restrooms: Indoor bathrooms are on site and marked. Please, no dogs in the bathrooms.

Food: Food will not be sold at this trial. There are many places within a short driving distance to get food. Snacks and water will be available for workers so be sure to volunteer where you can.

Measuring: Will be done throughout as needed based on judge availability.

Worker check-in: volunteers please check in with the worker coordinator 10 minutes prior to the start of the classes you will be working. See schedule for start times.

Additional info:

- Indoor crating is allowed but please conserve space. We ask that you please stack crates when possible. Chairs are allowed in the crating area unless we run out of space for dogs that need to be brought inside out of the heat.
 - We have scheduled classes to hopefully get everyone in and out so that no one is on site longer than necessary. If you have multiple dogs competing at multiple levels, this is unavoidable.
 - A hose will be available to cool down dogs.
 - **Course maps:** Course maps will be posted on site as per AKC rules. Maps will also be posted on the Fast Times website the day of the trial before the start of the first walk-thru (as long as they were provided to us by the judge). Maps will be posted under the "Agility Maps" tab for all trials. Printed maps will NOT be provided.
